



# Breakfast and Out of School Club

## Contract with Parents

- I consent for my child to attend Breakfast or Out of School Club. I understand that the club has policies and procedures (which are available on the school website), and that there are expectations and obligations relating both to the club and to myself and my child, and I agree to abide by them.
- I understand that Breakfast and Out of School Club is a play setting and that whilst my child is there, the Club is legally responsible for him/her.
- My child will be provided with a snack and drink whilst at the club unless otherwise requested.
- Once my child arrives at the Club, he/she will be in the care of the Club until collected and signed out by an authorised person.
- Breakfast Club – I will notify the club by 3.00pm if I want to cancel my child's place for the following morning.
- After-school club - I will notify the club before 12 noon if I am collecting my child from school on a day that he/she is booked to attend the club. I understand that I may be charged for the booked sessions unless I have cancelled the place by the specified time.
- I will pay promptly (within 10 working days) for all sessions attended otherwise my child's place in the Club is at risk. I understand that there is a £30 limit for outstanding debt per child on ParentPay and I understand that my child's place is at risk should the outstanding balance go over this amount.
- It is my responsibility to keep the school office informed of any alterations to the information regarding my child (contact details, medical conditions, etc).
- I accept that my child may take part in messy activities while at the Club. I understand that I can provide my child with appropriate clothing to accommodate this if I wish.
- Out of School Club is available at Chapel Haddlesey and Burton Salmon schools and closes at 5.30pm. If, due to unforeseen circumstances, I am going to be late, I will contact the school as soon as possible.
- If I do not collect my child by 5.30pm I will pay a charge of £2.50 per quarter of an hour to cover the costs of the staff who are legally required to supervise my child.
- If I do not collect my child by 6.00pm, and the club has been unable to reach me or any of my emergency contacts, I understand that the Club will follow its **Uncollected Children Policy** and contact Social Care.
- Whilst the Club tries to ensure the safety and security of items, I understand that it cannot be held responsible for loss or damage to my child's property whilst at the Club.
- I have read the club's **Behaviour Management Policy** and agree to its terms and appreciate that in some circumstances it may be necessary to exclude my child from the club, and I will pay for any missed sessions unless otherwise agreed with school.
- If there are any accidents or incidents at Out of School Club involving my child, I will be informed.
- If my child has an accident at the club, he/she will be treated by a qualified first aider and I will be informed as soon as possible. If my child needs urgent medical treatment and I am unavailable, a member of staff from the Club will sign any consent forms necessary for treatment on my behalf, as stated on the school's Child Record Form.
- Information held by the Club regarding my child will be treated as confidential. However, in certain circumstances, for example if there are child protection concerns, I understand that the club has a legal duty to pass certain information on to other agencies, including Police, Social Care, and health care professionals.
- I understand that aggressive and abusive behaviour towards staff will not be tolerated.
- I agree that I will not use a camera, mobile phone, or other mobile device on club premises.
